INTRODUCTION

This report provides a summary of the activities that have been carried out by SMIIIC for the period of 01 January – 31 December 2022 and is submitted by the SMIIIC General Secretariat.

SMIIIC is a member focused intergovernmental organization, who strives to achieve the goals and objectives set out in its internal documents and strategic plan.

COVID-19 Pandemic continued to shadow the first half of 2022, whilst the other half was a relief period where we could go back to normal and conduct physical meetings.

The number of activities increased dramatically during 2022, with the valuable contribution of all our stakeholders SMIIIC completed the first 2 yearly implementation plan of its 10 yearly SMIIIC Strategic Plan 2021-2030. We welcomed two new members: Azerbaijan and Tajikistan bringing the number of members to 47.

Simultaneously, 39 capacity building trainings in the field of metrology have been held. SMIIIC has conducted 9 training programs on the OIC/SMIIIC Halal Standards in order to aid the common use of standards within the OIC region. SMIIIC is conducting a series of trainings focusing on the knowledge and understanding of the OIC/SMIIIC standards, requirements, and implementation. Simultaneously, the standards development trainings are also conducted to enhance technical committee work. SMIIIC project “Promotion of OIC/SMIIIC Halal Standards use in the Asian and Arab Region” project with No: 2021-SMIIIC-926 has been final listed under the COMCEC Project Funding and completed.

SMIIIC has continued to work on the development of the much-needed common standards in the OIC and has to date published 53 (fifty-three) OIC/SMIIIC Standards, 20 (twenty) of them on halal issues.

OUR MEMBERS

SMIIC Family is growing

Our SMIIC family has continued to grow this year as well. 2 new members, Republic of Azerbaijan and Tajikistan joined the SMIIC family, as an intergovernmental organization, for which one of its main objectives is to support its members, takes great pride in its ever-growing number of members. During the 24th SMIIC Board of Directors (BOD) meeting, their SMIIC membership application was approved and now with its 47 (forty-seven) members including 3 observers from 4 different continents, SMIIC will constantly strive to play a vital role in its field of activities.

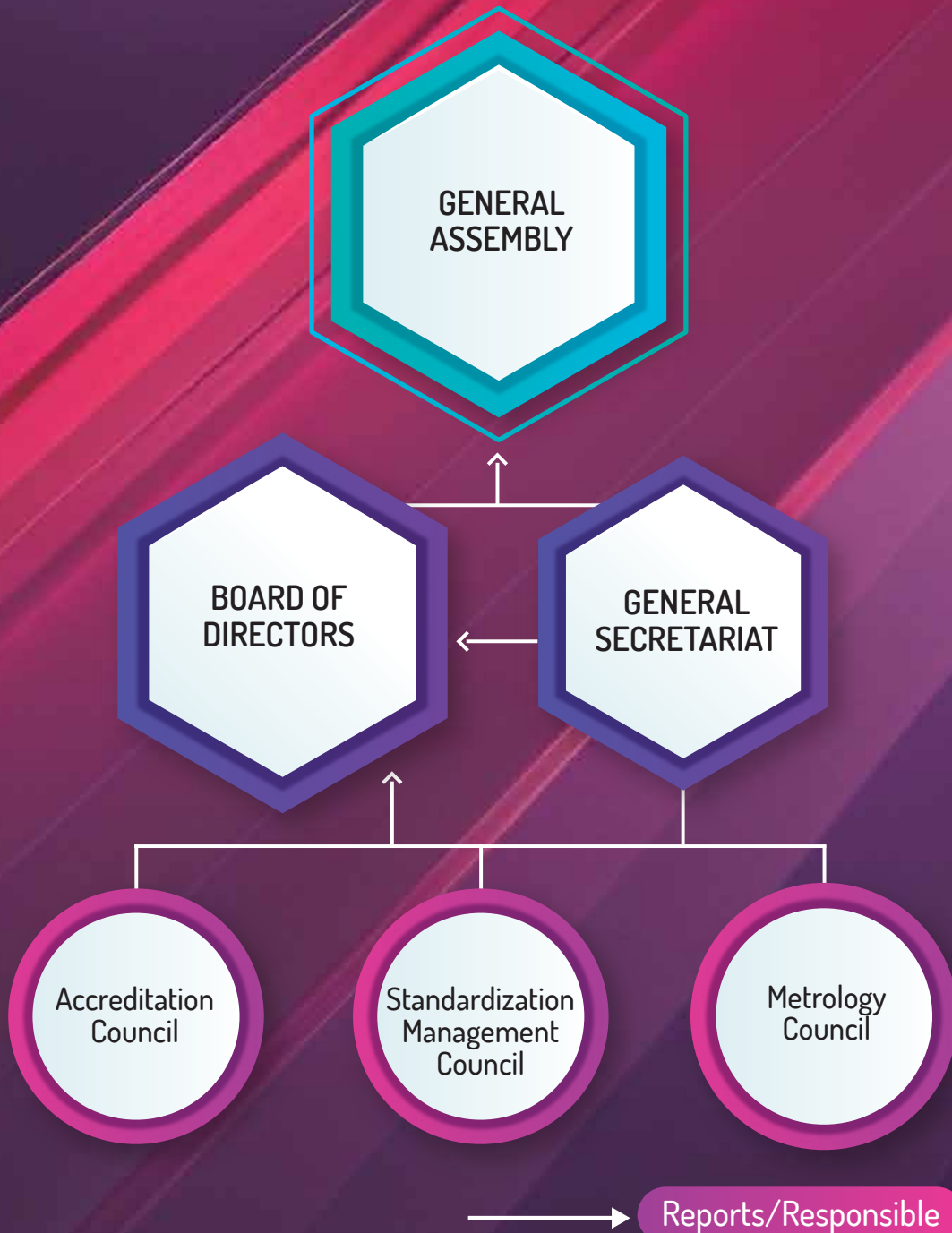

OUR GOVERNANCE ORGANS

The internal structure of the Institute comprises the following organs:



General Assembly

The General Assembly is the supreme decision-making organ of the SMIIIC and composed of the Member States.



The SMIIIC General Assembly is a yearly gathering of SMIIIC where all our members come together for an annual meeting to discuss and decide on resolutions, reports, and projects.

The 17th SMIIIC General Assembly (GA) Meeting was held in İstanbul, Republic of Türkiye on 22 November 2022. The meeting was attended by representatives from 30 SMIIIC Member States and 3 Observer States as well as the representatives from the Republic of Azerbaijan and Republic of Tajikistan as the new SMIIIC Member States, representatives of Organization of Islamic Cooperation (OIC), GCC Standardization Organization (GSO) and International Organization for Standardization (ISO) as observers.

During the working session, the Secretary General briefed the General Assembly on the latest developments and activities of SMIIIC as well as summarizing the activities of SMIIIC Councils, Technical Committees, Strategic Plan implementation and other important activities conducted since the 16th SMIIIC General Assembly Meeting. He also highlighted important issues that were discussed during the 23rd and 24th SMIIIC Board of Directors Meetings.

Furthermore, technical activities of the Institute were reported by the Chairs of the SMIIIC Councils. The General Assembly approved the report of external financial auditor and the SMIIIC Budget 2023 as well as the Annual Mandatory Contribution of SMIIIC Member States to 2023 SMIIIC Budget.

Board of Directors

The Board of Directors of the SMIIIC is the organ entrusted with the supervision of the execution of the programs, plans and activities of the Institute. The Board of Directors comprises of thirteen members, including the host country as the permanent member, elected by the General Assembly, on the basis of an equitable geographic distribution, for a term of three years.

23rd Meeting of the SMIIIC Board of Directors (BOD) was held on the 19 March 2022 in Riyadh, Kingdom of Saudi Arabia, with the kind hospitality of the Saudi Standards, Metrology and Quality Organization (SASO).

The meeting was chaired by H.E. Dr. Saad bin Othman AL-KASABI, Chairman of the SMIIIC Board of Directors (BOD). The meeting was attended by representatives from 12 Member States of the Board of Directors. General Secretariat presented its report on the developments and activities conducted since the last Board of Directors meeting and the report was welcomed by the Board of Directors members. Furthermore, two important Committees (a Permanent and an Ad Hoc Committee) have been established and appointments of membership positions under the Board of Directors as well as Assistant Secretary General have been successfully completed.

During the meeting, External Auditor Report for 2021 and the Progress Report on Two Year Implementation Plan (2021-2022) of SMIIIC Strategic Plan 2021-2030 were submitted and the Chairs of the SMIIIC Councils/Committee presented their reports on the latest developments and activities. Also, SMIIIC Annual Report 2021 was unanimously approved.

The result of the Chairman and Vice-Chairmen Elections of SMIIIC Board of Directors for the 2022-2024 term is:

- **Kingdom of Saudi Arabia** – Elected as the **Chairman of the BOD**
- **Republic of Turkey** – Elected as the **Vice-Chairman of the BOD** and appointed as the **Chair of the Finance Committee**
- **Republic of Cameroon** – Elected as the **Vice-Chairman of the BOD** and appointed as the **Chair of the Strategy Committee**
- **Islamic Republic of Pakistan** – Elected as the **Vice-Chairman of the BOD** and appointed as the **Chair of the Standardization Management Council**



As a tradition, the Twenty Fourth (24th) Meeting of the SMIIIC Board of Directors (BOD) was held one day prior to the General Assembly on 21 November 2022 in Istanbul, Republic of Türkiye following the regular meetings of Board of Directors Finance and Strategy Committees which were organized concurrently on the same day in the morning. The Board of Directors meeting was chaired by H.E. Dr. Saad bin Othman AL-KASABI, Chairman of the SMIIIC Board of Directors (BOD) and attended by representatives from 12 Members States of the Board of Directors.

As one of the most important outcomes, Board of Directors approved the membership applications of Republic of Azerbaijan which will be represented by Azerbaijan Standardization Institute (AZSTAND) as the national body and Republic of Tajikistan which will be represented by Agency of Standardization, Metrology, Certification and Trade Inspection under the Government of the Republic of Tajikistan (TAJIKSTANDARD) as the national body, bringing the number of SMIIIC Members to 44 along with 3 Observers.

OUR HIGHLIGHTS

Standardization Management Council (SMC)

Standardization Management Council is the organ assigned the task of coordinating the development of OIC/SMIIC standards in cooperation with Member States. Standardization Management Council coordinates and oversees the performance of the Technical Committees.

During the last year, SMC has continued building up the future activities of the technical committees and following-up their performance on ongoing standards projects.

- The Fifth (5th) Meeting of the SMIIC SMC held on 20 November 2022 in Istanbul. The following are the proceedings:
- Approval of "SMIIC Code of Ethics for Technical Work"
- "Workshop on SMC Roadmap" will be held together with the upcoming SMC Meeting.
- The approval of TC Chairs:
- TC 16 – Halal Pharmaceuticals : Dr. Noraida Mohamad ZAINOOR
- TC 17 – Handicraft: Eng. Hussein Ahmed Mohamed IBRAHIM
- Reallocation of the secretariat of TC 2 – Halal Cosmetics Issues to Kingdom of Saudi Arabia. Mr. Abdulkareem Albabteen has been assigned as the Secretary of TC 2 by Kingdom of Saudi Arabia.

Standardization Activities

The core business of SMIIC is to develop and publish OIC/SMIIC Standards and technical specifications that meet the evolving needs of OIC-wide businesses and other organizations. This important work brings concrete benefits, such as: *improving safety, quality and reliability of products and services.*

The year 2022 has also brought about many unexpected challenges following the impacts of ongoing COVID-19 pandemic yet we continued our commitment to improving our technical work. Hence, by benefiting from all types of technological tools, we have carried out our main tasks in SMIIC Technical Committees to work on and publish new OIC/SMIIC standards.

Assessment (SMiIC/CCA)

OIC/SMiIC standards are developed by experts, within TCs. TCs are made up of representatives of industry, NGOs, governments and other stakeholders, who are put forward by SMiIC's members. Each TC deals with a different subject.

Technical Committee Week 11 Meetings

11th Technical Committee Week (TC Week 11) was organized on 17-21 September 2022 in İstanbul, Republic of Türkiye. All committees including SMIIIC/CCA held their plenary meetings for the first time physically after 3 years of pandemic period. The online participation to the meetings was also possible for members who could not attend physically.

11th SMIIIC Technical Committee (TC) Week Meetings were organized with the participation of 69 delegates from Bangladesh, Bosnia and Herzegovina, Cameroon, Egypt, Indonesia, Iran, Iraq, Jordan, Kingdom of Saudi Arabia, Kuwait, Libya, Malaysia, Morocco, Pakistan, Palestine, Qatar, Senegal, Sudan, Thailand, Tunisia, Türkiye, Uganda and International Islamic Fiqh Academy (IIFA).

The plenary meetings were effective and fruitful in which Technical Committees worked on their projects, strategic business plans.

Committee on Standards for Conformity Assessment (CCA)

Committee on Standards for Conformity Assessment (CCA) has been established for preparation of guides/standards on criteria for bodies involved in testing, calibration, certification, inspection, accreditation, their operation and assessment, and other related standards and especially halal conformity assessment and accreditation guidelines or standards.

SMIIIC/CCA is the committee which is responsible for the development of OIC/SMIIIC standards on conformity assessment and accreditation. Within the committee, 6 OIC/SMIIIC standards have already been developed on this scope of which OIC/SMIIIC 2 and 3 standards are the main standards.

11th Meeting of SMIIIC/CCA was held on 17 October 2022 in hybrid format in İstanbul, Republic of Türkiye and was also technically hosted by General Secretariat.

The Committee further decided to activate of the clarification process within SMIIIC/CCA. One of the main tasks of the CCA is defined as "To provide answers to the clarification requests on the relevant SMIIIC/CCA guides or standards which is submitted by any SMIIIC Member State or liaison organization" in Clause 4 of Terms of Reference of SMIIIC/CCA. To be able to activate this task, a maintenance group has been established at the meeting by approving the clarification process document to conduct this activity.

The maintenance group is expected to develop common positions on the clarification requests received by SMIIIC Member States or liaison organizations on any clause of the OIC/SMIIIC standards which are developed and published within the scope of SMIIIC/CCA.

New OIC/SMIIC Standards Published in 2022

The standards published in 2022 are as follows:

- TC 9 Textiles and Related Products published a new standard ***OIC/SMIIC 27: 2022 – Woven Carpets used for Masjids***. This standard specifies machine-made woven carpets with cut or loop pile or both types of piles for use in Masjids.
- TC 8 Leather and Tanning Material published a new standard ***OIC/SMIIC 37: 2022 – Halal Products- Usage of Animal Bone, Skin and Hair- General Guidelines***. This standard gives practical guidelines for the relevant industries of the usage of animal bone, skin and hair in accordance with Islamic rules.
- TC 6 Agricultural Products published a new standard ***OIC/SMIIC 47: 2022 – Dates for Industrial Purposes***.
- TC 11 Halal Management Systems published a new standard ***OIC/SMIIC 51:2022 – Hygiene and Sanitation Management System – Requirements***.
- TC 1 for Halal Food Issues published a new standard ***OIC/SMIIC 23:2022 – Feeding Stuffs for Halal Animals – General Requirements***.
- TC 16 for Halal Pharmaceuticals Issues published a new standard ***OIC/SMIIC 50-1: 2022 – Halal pharmaceuticals - Part 1 - General requirements***.
- TC 14 Petroleum and Related Products published 4 new standards.

- The SMIIC Committee on Standards for Conformity Assessment (CCA) published ***OIC/SMIIC DS 57 Conformity Assessment – General Requirements for the Operation of Various Types of Bodies Performing Halal Inspection***.

The standards development process incorporated hours of hard work of experts from each of the Technical Committee, Member States and from the International Fiqh Academy (liaison in the Technical Committees) and has worked through step by step every aspect of the draft documents producing the final standards. SMIIC would like to thank all experts who have put in time and effort in the development of the standard.



SMIIC Information System

SMIIC Information System (IS) was established and launched in 2015 as an electronic collaborative environment to increase the efficiency of communication level among Member States and a database storing all technical works and documents of SMIIC within the scope of work especially for the activities of the Technical Committees (TCs).

It has been actively used since then by the secretaries, chairs and experts/members of the TCs and its sub structures for all steps of standardization work from preliminary stage until the publication of OIC/SMIIC standards. SMIIC IS is also used to store the administrative/meeting documents of SMIIC General Assembly and Board of Directors and the documents of SMIIC Councils as well as the information on SMIIC partners. SMIIC IS is linked to the official website of SMIIC which allows to keep the site up to date and ensure the online sales of the OIC/SMIIC standards.

SMIIC Website:

The Standardization and Metrology Institute for the Islamic Countries (SMIIC) is always looking for new ways to improve communication and promote cooperation among its members. As part of this effort, we are pleased to announce the new features added to our website – addition of Arabic and French versions of the website and the ability to purchase trainings online.

New Feature on SMIIC Website: Online Training Programs

The objective of this new feature is to provide our trainings related to SMIIC standards and work procedures to a wider audience. In addition to our member states, we will now be able to offer our trainings to private companies and institutions all around the world. This new feature is in line with our new project "SMIIC Academy" which we are launching soon.

We have received immense demand from our stakeholders all over the world requesting training. By offering our trainings online, we aim to increase accessibility and reach a larger audience. This will also provide an additional source of revenue for SMIIC and help us achieve our goals.

We believe that this new feature on our website will benefit our members, private companies and institutions, and contribute to the success of SMIIC's initiatives. We are confident that it will help us promote communication and cooperation among our members, and support our mission of promoting standardization and metrology in the Islamic world.

Metrology Council (MC)

MC consists of a chair and members from national metrology institutes of the Member States and Observers of SMIIC. SMIIC MC aims to achieve uniformity in metrology and laboratory testing among Member States.

Metrology Activities

Metrology as the science of measurement showed us its importance once again during the pandemic period. Metrology and laboratory services have provided an essential contribution to the diagnostic process with high-quality and accurate infrastructure. In view of this fact, we continued our metrology activities during 2022 by holding meetings and the planned trainings for capacity building as per the SMIIC MC Work Plan 2021 – 2023.

10th SMIIC Metrology Council Meeting

The 10th Meeting of the SMIIC Metrology Council (MC) was held on the 16 May 2022 and hosted by the SMIIC General Secretariat and TÜBİTAK UME, the institute holding the chairmanship of the SMIIC MC. The meeting was attended by 45 representatives from a total of 20 Members.

Representatives from the General Directorate of Metrology (The Republic of ALBANIA) and Azerbaijan Metrology Institute (Republic of AZERBAIJAN) attended the meeting as invited guests.

Representative from the Gulf Association for Metrology (GULFMET) attended the meeting as a liaison organization.

Brief summary:

- “Progress on implementation of SMIIC MC Work Plan” was presented regarding the actions taken by the Meeting and the ones planned to be done by the end of 2021 regarding the Work Plan. The participants were informed on the trainings, survey on the ILCs requirements and further process related to the planning the ILCs requested.
- “Categorization of Member States and roadmap for transition from low to high category” was presented with general overview of the current situation as well as emphasizing the actions need to be taken to improve the capability of relatively less developed countries within SMIIC MC. The importance of transition to upper category and the desire to see all SMIIC Member States in the Category 1 was emphasized by the SMIIC MC Chairman.

- “Gravity Metrology and Gravity Activities at TÜBİTAK UME”.

11th SMiIC Metrology Council Meeting

The 11th Meeting of the SMiIC Metrology Council (MC) was held in hybrid format during 28-29 October 2022 in Almaty, Republic of Kazakhstan. It was hosted by the SMiIC General Secretariat in coordination with KazStandard, department of the Technical Regulation and Metrology Committee of the Ministry of Trade and Integration of Republic of Kazakhstan (KAZMEMST).

The meeting was attended by 47 representatives (30 physically and 17 online) from a total of 23 Members.

During the meeting presentations were given on the following:

1. Progress on implementation of SMiIC MC Work Plan 2021-2023 V2
2. Categorization of Member States and roadmap for transition from low to high category
3. Halal activities in Member States
4. Latest development in Member States
5. SMiIC MC Inter Laboratory Comparisons
6. EMCIC Project

The members discussed the possibilities for improvement and capacity building of member states to move from category 3 to category 1.

MC Council members also discussed the developments regarding the EMCIC project. The MC Trainings and capacity building projects will continue as planned in the SMiIC MC Work Plan 2021-2023 V2.

The SMIIC MC, in order to achieve its objectives to harmonize and facilitate the activities in metrology services in Member Countries based on international arrangements and regional metrology organization membership requirements has been organizing trainings and relevant metrological activities. The SMIIC MC aims to contribute in enhancing the technical and metrological capabilities of Member States to facilitate removal of technical trade barriers. In line with these objectives, the SMIIC MC Work Plan 2021-2023 was prepared by the Task Force Group which was constituted during the 8th SMIIC MC meeting and approved by the SMIIC MC by correspondence.

The SMIIC MC Work Plan 2021-2023 covers the main activities planned to be realized by the SMIIC MC Member States for three years and is coordinated by the MC Chairmanship. Due to the COVID-19 pandemic, some activities i.e. training, capacity building, consultancy, etc. have been organized online and the form of the other activities will be decided mutually with the involvement of the member NMIs. This plan may be subject to intermediate revision at the SMIIC MC meetings in case it is requested by the members.

SMIIC Metrology Council Technical Capacity Building Trainings:

Due to the COVID-19 pandemic, the planned training activities were commenced to be conducted online by the host National Metrology Institutes. The training requirements were planned to be covered by volunteer members (Training fields and details are presented in the SMIIC MC Work Plan 2021 - 2023). All trainings were coordinated by TUBITAK UME as the NMI holding the SMIIC MC Chairmanship and SMIIC General Secretariat. Information about the 23 trainings successfully realized via Zoom platform are given in the table below.

The MC 2021-2023 Working Plan includes training and capacity building trainings on:

- a Scientific Metrology Training (11 trainings)
- b Legal Metrology Training (3 trainings)
- c Training Related to Halal Activities (7 trainings)
- d Calibration Trainings (8 trainings)
- e Proficiency Testing Training (3 trainings)
- f Joint Work, Consultancy, R&D and Workshops (11 programs)

Accreditation Council (AC)

Accreditation Council (AC) consists of members from national accreditation bodies authorized by Member States and Observers of SMIIC. The chair and 12 members from national accreditation bodies authorized by Member States shall be appointed or elected by the Board of Directors for the management of AC, on the basis of an equitable geographic distribution, in accordance with the Rules of Procedure.

AC is the organ carrying out activities aimed at the establishment of an accreditation scheme in the OIC Member States. AC is responsible for supporting actions for establishing a sound accreditation system OIC-wide and raise awareness of accreditation concept within the Member States.



The composition of the Members of the Management of SMIIC AC for 2022-2024 term was determined at the 22nd SMIIC Board of Directors on 01 November 2021 in Al-Madinah Al-Munawarah, Kingdom of Saudi Arabia and the information of new members is available via <https://www.smiic.org/en/accreditation-council-ac>



Fourth Meeting of the Management of the SMIIIC Accreditation Council (AC)

After the SMIIIC BOD election of twelve (12) Member States to the Accreditation Council for the 2022 – 2024 term as per SMIIIC Board of Directors Resolution 20/2021, the Fourth Meeting of the Management of SMIIIC AC was held on 20 June 2022 in İstanbul, Republic of Türkiye.

As per Accreditation Council Resolution 03/2022; the Management of SMIIIC Accreditation Council has elected unanimously Eng. Lana Marshdeh, Director of Jordan Accreditation and Standardization Systems – Accreditation Unit (JAS-AU) of Jordan as the Chair of SMIIIC AC, and has elected unanimously Mr. Zafer Soylu, Chairman of the Board of Directors of Halal Accreditation Agency (HAK) of Türkiye as the Vice-Chair of SMIIIC AC, both ending on 31 December 2024 and the elections have been approved at the

Establishment of a Task Force Group

Following the approval of the OIC Global Halal Quality Infrastructure (OHAQ) and Informative Note documents with Board of Directors Resolution 03/2021 of the 21st SMIIIC Board of Directors Meeting, the Management of SMIIIC AC (MAC) members discussed the activation of OIC Global Halal Quality Infrastructure and decided to establish a Task Force Group (TFG) with the composition of Cameroon, Egypt, Morocco, Saudi Arabia, Tunisia, United Arab Emirates, Türkiye (Chair of TFG) and the secretariat of TFG provided by General Secretariat. The TFG main task is to study the possible designated structure proposals through correspondences and/or physical/online meetings and to submit the outcomes of the study to General Secretariat within three months in writing to be submitted to the next MAC Meeting. 1st TFG Meeting was held on 31 October–01 November 2022, İstanbul, Republic of Türkiye while 2nd TFG Meeting was held on 26–27 December 2022 in İstanbul, Republic of Türkiye, in hybrid format. The TFG is expected to finalize its study in the first half of 2023 and to submit the outcomes to the consideration of MAC.

Members of the Management of SMIIIC AC are determined to activate the OIC Global Halal Quality Infrastructure, based on the principles that have been set in its structure, and by making use of available regional/international structures while keeping its unique identity that serves the needs of all Muslims around the world.

The OIC Global Halal Quality Infrastructure will be a system with a well-designed structure from which all Member States could get benefit and also the OHAQ is expected to assist Member States in setting up proper national quality infrastructure system along with enhancing the existing ones based on the OIC/SMIIIC standards.

Training Activities

One of the Strategic Priorities (Goals) of SMIIIC is “Support the enhancement of quality infrastructure and interconnectivity of members” in order to achieve our goal, we work to support our members in improving their infrastructure by giving trainings in different fields: metrology, standards and accreditation, with a special focus on OIC/SMIIIC Standards and Directives/SMIIIC Information Systems training.

We continued to conduct various training activities in 2022 both virtually and physically, some of these are mentioned below:

OIC/SMIIIC 1:2019 General Requirements for Halal Food- Foundation Training in Arabic

SMIIIC conducted the OIC/SMIIIC 1 Halal Foundation Training in Arabic on 24-27 January 2022 virtually. 43 participants from Algeria, Egypt, Iraq, Jordan, Libya, Morocco, Palestine, Qatar, Sudan, Saudi Arabia, Somalia, Tunisia, United Arab Emirates, and Yemen attended the training. The training was the first of a series of training courses held by the SMIIIC General Secretariat in 2022.

The training aimed to give the foundation knowledge regarding halal food, the halal industry, requirements and implementation of the OIC/SMIIIC 1:2019 General Requirements for Halal Food. The training program included:

- OIC/SMIIIC Standards on Halal Issues

The training was very productive and SMIIIC General Secretariat will continue to support our members wherever necessary.

- Evaluation Test

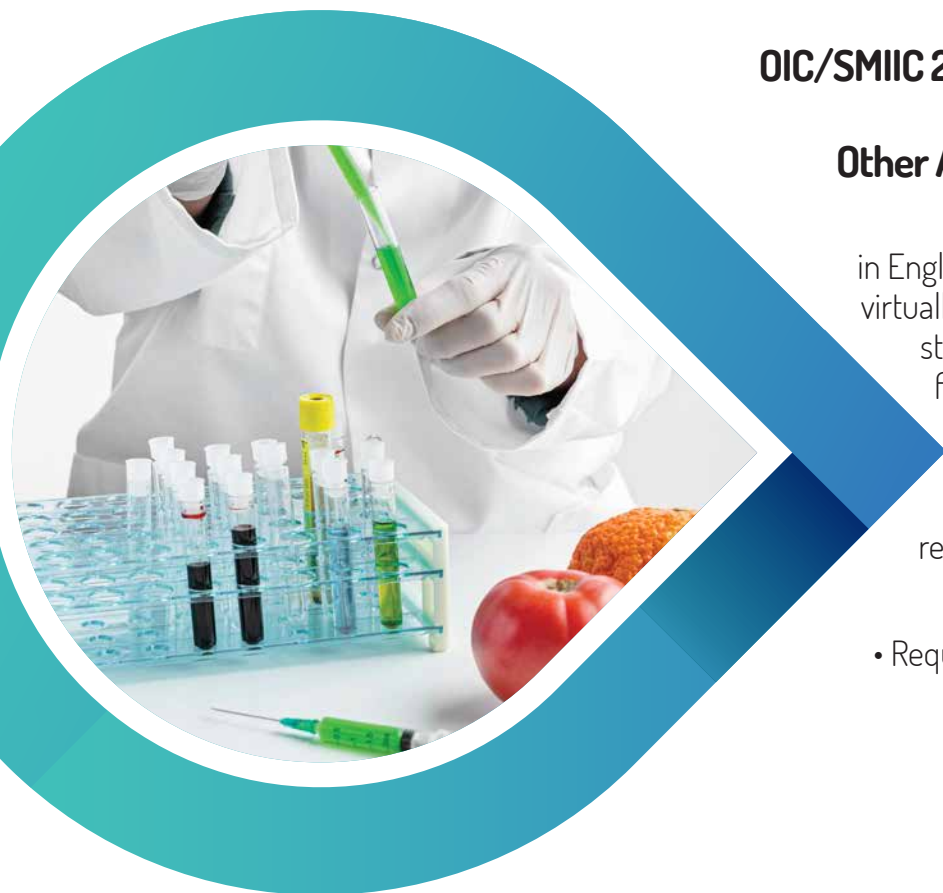


OIC/SMIIC 24:2020 General Requirements for Food Additives and Other Added Chemicals to Halal Food, Foundation Training

“OIC/SMIIC Halal Products Standards and Testing”

training course was held between 22-26 August 2022 in Uganda, which was organized by SMIIC in collaboration with COMSTECH Secretariat and Islamic University in Uganda (IUIU) with an aim to encourage the harmonization of halal standards used in the OIC Member States and internationally by aiding in the adoption and use of the OIC/SMIIC halal standards. The training course was designed to train the participants from Africa LDC-OIC Member States regarding the procedures for adoption, implementation and use of the OIC/SMIIC halal food standards.



Other Activities:

8th World Halal Summit and 9th OIC Halal Expo

8th World Halal Summit (WHS) under the theme of: “For Sustainable Trade: Explore All Aspects of the Growing Global Halal Industry” was held during the 24-26 November 2022 in Istanbul Expo Center (IFM) Istanbul/Turkey; simultaneously with 9th OIC Halal Expo (26-27 November 2022).

The 8th World Halal Summit was participated by 69 high-level speakers from 19 different countries bringing together experts from all over the world to discuss key issues related to the global halal industry. In the conferences where the participants were evaluated, the speakers presented their valuable original works under 12 different session titles.

The 9th OIC Halal Expo housed 446 domestic and foreign companies from 39 different countries. The World Halal Summit and the 9th OIC Halal Expo was a successful event which hosted 31,905 visitors from 117 countries

COMCEC Project Funding - 2021-SMIIC-926 Project

SMIIC conducted 2 training programs on the OIC/SMIIC Halal Standards which was final listed to be funded by the Standing Committee for Economic and Commercial Cooperation (COMCEC) of the Organization of Islamic Cooperation (OIC under project the “Promotion of OIC/SMIIC Halal Standards use in the Asian and Arab Region” project with No: 2021-SMIIC-926.

The objective of the training program was to encourage the harmonization of halal standards used in the OIC and internationally by aiding in the adoption and use of the OIC/SMIIC halal standards. The program aims to inform representatives from SMIIC/OIC Member States.

The project aimed to increase the awareness of SMIIC activities and OIC/SMIIC standards; to give the necessary know-how in the requirements of the halal quality infrastructure, the process of building this infrastructure in a Member State and the halal auditing methodology according to OIC/SMIIC standards. These trainings will aid in the use of the OIC/SMIIC standards as common standards and hence to decrease the technical barriers to trade in the OIC region.

The project included 2 trainings: each training was 3 days, one training in Kazakhstan for the Asian countries and the other training, online for the Arab speaking SMIIC countries. The trainings included content regarding SMIIC, halal market, halal food, OIC/SMIIC standards development, adoption and use of the standards was given on the first day.

During the second and third day, specific foundation knowledge was given on the use of OIC/SMIIC 1:2019 General Requirements for Halal Food, followed by an evaluation test and survey.

The trainees received a certificate after fulfilling the necessary requirements of the training.

The OIC SMIIC 1 Halal Auditor training for Arab region was held between 10-12 October 2022 virtually, by the SMIIC General Secretariat and participated by 38 delegates from Algeria, United Arab of Emirates, Iraq, Jordan, Mauritania, Morocco, Oman, Palestine, Sudan and Tunisia.

The OIC SMIIC 1 Halal Auditor training For Central Asian region was held between 27-29 October 2022 Almaty, Kazakhstan and participated by 24 delegates from, Kazakhstan, Azerbaijan, Uzbekistan, Kyrgyzstan, Tajikistan, and Russian Federation.

Dubai Expo 2020

SMIIC took part in EXPO 2020 being held during 1st October 2021 – 31st March 2022 in Dubai, United Arab Emirates. SMIIC has been taking part in the coordination meeting for the EXPO 2020 and as a side event in coordination with ICDT, ICCIA and IsDB. SMIIC has been the OIC Institution Coordinator for a specific period of time.

The participation of OIC in the Expo 2020 Dubai with its pavilion has been an opportunity to showcase OIC and its institutions achievements, services and activities for the benefit of the Ummah and how they contribute to improving the image of Islam worldwide.

Therefore, in line with the OIC Institutions' activities during Expo 2020 Dubai, the "Special OIC Halal Conference" was successfully held on 14 February 2022 at Terra Auditorium – Sustainability Pavilion.

Secretary General H.E. Mr. İhsan ÖVÜT and accompanying SMIIC Staff informed the physical and online audience on the basic pillars of "Halal Quality Infrastructure" through OIC/SMIIC Standards and its contribution to the OIC Member States.

SMIIC is always committed to conduct necessary technical activities especially on development of quality infrastructure of the Member States in line with relevant OIC Resolutions and relevant Sustainable Development Goals (SDGs) of the UN as the technical organ of the OIC.



OUR PARTNERS

Cooperation with International and Regional Organizations

Partnership and collaboration are at the heart of SMIIC's visibility, and in 2022, we continued to work with our partners leading to mutual benefit for all.

SMIIC has signed Memorandum of Understanding (MOUs) with International Trade Center (ITC), United Nations Economic Commission for Europe (UNECE), United Nations Industrial Development Organization (UNIDO), African Organisation for Standardisation (ARSO), Arab Industrial Development, Standardization and Mining Organization (AIDSMO), GCC Standardization Organization (GSO), the GCC Accreditation Center (GAC) and Arab Accreditation Cooperation (ARAC). During 2022, we strengthened our cooperation and coordination with sister organizations in the OIC family: International Islamic Fiqh Academy (IIFA), Islamic Centre for Development of Trade (ICDT), Statistical, Economic and Social Research and Training Centre for Islamic Countries (SESRI), Islamic Chamber of Commerce, Industry and Agriculture (ICCIA), Islamic Organization for Food Security (IOFS) and Ministerial Standing Committee on Scientific and Technological Cooperation of the OIC (COMSTECH).

“SMIIC STRATEGIC PLAN 2021-2030”

Our new SMIIC Strategic Plan 2021-2030 became effective on 1st of January 2021, after its approval during the 15th SMIIC General Assembly. The approved Strategic Plan gives the general framework plan towards achieving our vision and accomplishment of our high strategic goals.

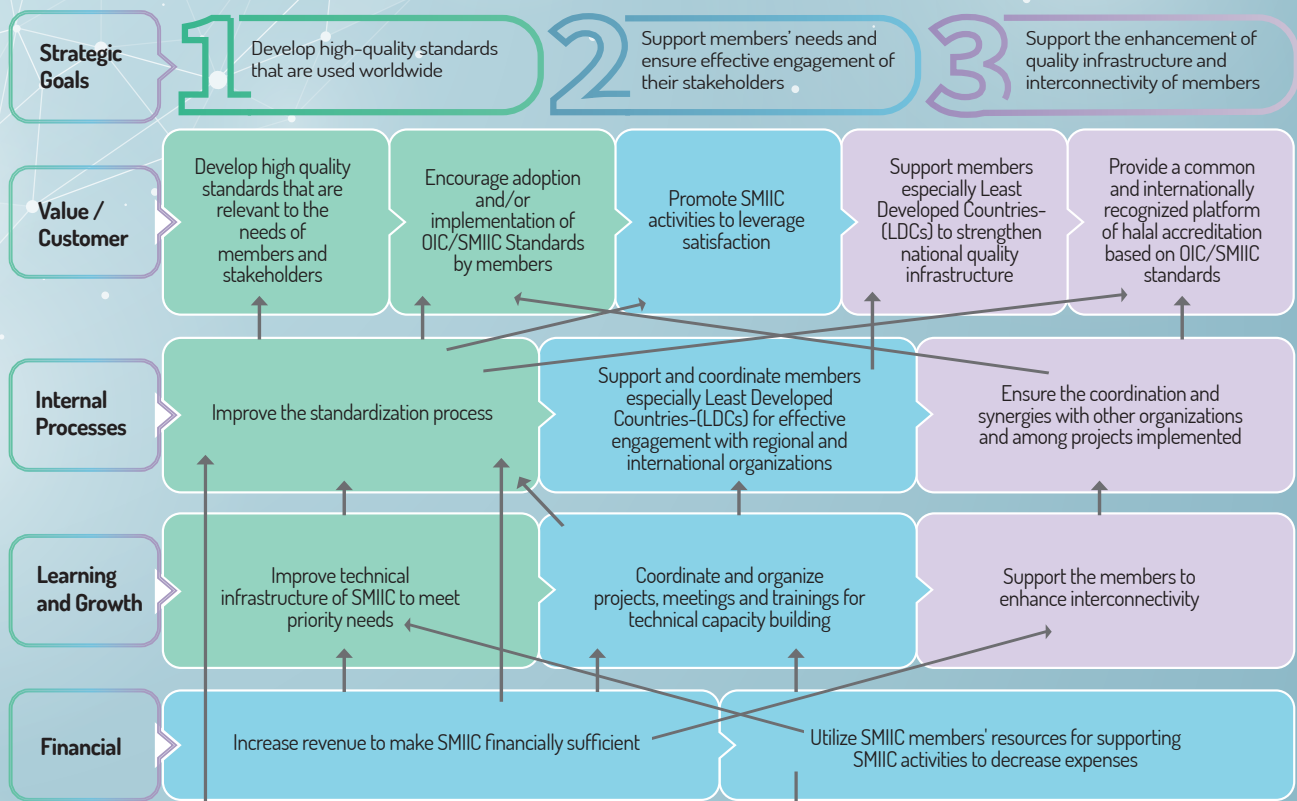
In order to put our strategic plan in practice successfully, it was necessary to develop two-yearly implementation plans that will outline the actual actions we will take to achieve our goals. The first Implementation Plan for the term 2021-2022 was approved during the 21st Board of Directors meeting and our new journey was started.

For executing our implementation plan, we launched 13 (thirteen) Strategic Initiatives including 20 (twenty) projects in different areas for the improvement of our Members States' quality infrastructure, capacity building trainings, supporting Least Developed Countries, conducting joint programs with our partners, improving our standards to support the intra-OIC trade, enhancing the connectivity between our members, developing our staff and improving our internal processes and finance.

SMIIC has worked actively to execute the approved Implementation Plan of SMIIC Strategic Plan 2021-2030 for the term (2021-2022) since the early stages of its approval. The necessary steps were taken to plan, commence and complete the strategic initiatives. In this regard, SMIIC has set 20 (twenty) projects to execute these initiatives in the best way to accomplish the strategic objectives. While executing the plan, SMIIC General Secretariat has achieved tangible success in the implementation of many activities that contributed significantly to achieving the specific targets of the Reporting Period (01 Jan 2021 – 30 Sep 2022). SMIIC General secretariat has conducted 6 (six) surveys to learn about the satisfaction degree rate of its Member States. The Satisfaction Degree Rate was 88%.

Two-Year Implementation Plan (2023-2024) of SMIIC Strategic Plan 2021-2030 was submitted to and approved during the Twenty Fourth (24th) Meeting of the SMIIC Board of Directors (BOD) which was held on 21 November 2022 in İstanbul, Republic of Türkiye, and has become effective from 01 January 2023.





OUR SCORECARD

1. Expert engagement:

454 experts from SMIIIC Member States, GSO and IIFA participated and contributed to the technical work during the 10th SMIIIC Technical Committee Week Meetings.

Representatives of IIFA and GSO as liaison organizations and 205 attendees from 22 SMIIIC Member States participated in 11th SMIIIC Technical Committee Week Meetings. 69 delegates physically attended the 11th TC week meeting from Bangladesh, Bosnia and Herzegovina, Cameroon, Egypt, Indonesia, Iran, Iraq, Jordan, Kingdom of Saudi Arabia, Kuwait, Libya, Malaysia, Morocco, Pakistan, Palestine, Qatar, Senegal, Sudan, Thailand, Tunisia, Türkiye, Uganda and International Islamic Fiqh Academy (IIFA).



2. Online Sales:

Online sales system of OIC/SMIIIC standards on SMIIIC website which was launched in 2017 has become more dynamic during 2022 recording 166 standards been purchased from all around the world.



3. Standards published in 2022

In 2022, SMIIC has published a total of 11 standards.

✓ **- OIC/SMIIC 27: 2022 – Woven Carpets used for Masjids.**

This standard specifies machine-made woven carpets with cut or loop pile or both types of piles for use in Masjids.

✓ **- OIC/SMIIC 37: 2022 – Halal Products- Usage of Animal Bone, Skin and Hair- General Guidelines.**

This Standard gives practical guidelines for the relevant industries of the usage of animal bone, skin and hair in accordance with Islamic rules.

✓ **- OIC/SMIIC 47: 2022 – Dates for Industrial Purposes**

This standard is concerned with the requirements that shall be fulfilled in whole, pitted or un-pitted dates intended for industrial purposes; including human nutritional products, animal feed and non-nutritional products. It does not include dates intended for direct human consumption or date products such as date pieces and mashed dates.

✓ **- OIC/SMIIC 51:2022 – Hygiene and Sanitation Management System – Requirements**

This standard specifies requirements for a Hygiene and Sanitation Management System when an organization:

a) needs to demonstrate its ability to consistently provide products and services that meet customer and applicable statutory and regulatory requirements, and

b) aims to enhance customer satisfaction through the effective application of the system, including processes for improvement of the system and the assurance of addressing the customer needs and conformity to relevant statutory and regulatory requirements.

✓ **- OIC/SMIIC 23:2022 – Feeding Stuffs for Halal Animals – General Requirements**

This standard specifies the basic requirements that shall be followed at any stage of feed preparation or production (from raw materials to final products) including receiving, sorting, preparation, mixing, processing, packaging, labelling, handling, transportation, distribution and storage of any materials intended for halal animal feeding based on Islamic rules.

✓ **- OIC/SMIIC 50-1: 2022 – Halal pharmaceuticals – Part 1 – General requirements**

This standard defines the basic requirements in the manufacturing and transportation of halal pharmaceuticals based on Islamic rules.

✓ **-OIC/SMIIC 57 :2022 – Conformity Assessment – General Requirements for The Operation of Various Types of Bodies Performing Halal Inspection**

This document specifies the general requirements for inspection bodies performing halal inspection to apply to halal-related inspection activities.
